Subject: Reorganization of the Acquisition, Property, and Support Functions at the National Business Center (NBC) effective January 27, 2002.

The acquisition functions at the NBC are now consolidated under the National Acquisition Division (BC-660). This Division consists of a Policy Analysis and Oversight Staff (BC-661) and four Branches. The Branches are the Information Technology Branch (BC-662), Services and Supplies Branch (BC-663), Construction, Architecture and Engineering Branch (BC-664), and the Space Leasing Branch (BC-665).

Division management staff are as follows:

National Acquisition Division - Ron Corsi
Information Technology Branch - John Sherman / Gary Meade (rotating acting)
Services and Supplies Branch - Joe Bogus
Construction, Architecture and Engineering Branch - Liz McDill
Space Leasing Branch - Dave Cunningham

Branch chiefs should be contacted regarding questions or issues specific to their area of responsibility. A vacancy announcement is currently out for the Information Technology Branch Chief.

The Policy Analysis and Oversight Staff includes Dave Wunder as the IDEAS Coordinator and Gwen Burton as the Business Utilization Development Specialist.

IDEAS Purchase Requisitions (PRs) should be routed to the newly established BC-660, National Acquisition Division Team cabinet. Branch managers will make assignments from the National Acquisition Division Team cabinet to specific contract specialists, using the workload management function of IDEAS.

The Denver Center Support Services Group and the Property Operations/Systems Group are now consolidated under a new Division within NBC called the National Property and Support Program Division (BC-650). The Division Chief position is currently vacant but will be advertised in the near future.

This new division is made up of a Policy Analysis and Oversight Staff (BC-651) and two Branches. The Policy Analysis and Oversight Staff consists of Lynne Lotvedt, Jim Crews, and Lee Campbell. Lynne, Jim, and Lee will continue to perform their current duties. The Branch Chief of the new National and Denver Centers Support Programs Branch (BC-652) is Bob Pinkney. The Branch Chief position for the new Property Operations Branch (BC-653) is also vacant and will be advertised in the near future.


