We provide on-site access to the BLM library collection and Web access to our catalog via the intranet, along with basic reference services to all customers, including the public. Our professional librarians also provide a comprehensive range of services to BLM employees nationwide:

## Micrographic Services

### Your Connection to the Past, Present, and Future

Our microform specialists have consolidated the historical cadastral survey information for each township in the 13 Western States (approximately 325,000 masters). These records are stored in a secure, temperature-controlled environment. We maintain the master film of the Cadastral Survey Field Notes system, ensuring accurate filing and providing restorative services. Duplicates of the master film are available upon request. We can produce microfiche copies of individual townships and customized information sets from mineral surveys, homestead entry surveys, plats, and field notes. Our fees cover supplies only, at \$0.25 per sheet of microfiche (up to six plats or up to 35 field note images) for BLM offices; we charge \$0.50 per sheet for outside orders. Duplicate copies of plats are provided in roll film and microfiche format. Our fees for 16-mm or 35-mm roll film duplication are \$5 per 100-foot roll for BLM offices and \$20 per 100-foot roll for outside orders.
